Notification for engagement of Principal, Academic (Veda Teachers), Allied Academic (Modern Subjects), and Non-Academic services at the campuses of the Rashtriya Adarsh Veda Vidyalayas affiliated to Maharshi Sandipani Rashtriya Vedavidya Pratishthan

The Maharshi Sandipani Rashtriya Vedavidya Pratishthan invites applications for engagement of **Principals, Veda teachers, other Allied Modern Subject teachers, and for Non-teaching services** on contractual/outsourch basis for the year 2025-26 in the Rashtriya Adarsh Veda Vidyalayas under its management at : (I) Ujjain, Madhya Pradesh (II) Puri, (Odisha) (III) Dwarka, (Gujarat) (IV) Guwahati, (Assam) (V) Shringeri or nearby place (Karnataka) and (VI) Badrinath or nearby place (Uttarakhand). These engagements will be solely on contract/outsourch basis. This is NOT a post-based service. No post has been sanctioned, and no permanent appointment is likely to be made at any time.

The Pratishthan reserves the right to prepare a panel for teaching **Veda and Allied Modern Subjects and Non-academic services** for absorption into the Vidyalaya system. Therefore, a uniform engagement policy or all engagements in one go cannot be enforced for all those who are in the select panel. No posts have been sanctioned. Engagements will be done as per requirement.

It is mandatory to **apply separately** for each subject. The last date for filling the application form will be **26/09/2025**. A self-attested copy of the application form must reach the Pratishthan's office via speed post by **26/09/2025**. Application received at the Pratishthan's office after the specified date will not be entertained.

- (1) No other allowance will be admissible over and above the said honorarium. Govt. specified Taxes/TDS will be deducted. *This is NOT a post-based service. Permanent post will not be sanctioned, and permanent appointment will not be made .
 - (2) Teaching arrangements will be made in each Shakha only if five or more students are available.
 - (3) If found suitable for teaching the Vedas, but are found to be in need of experience and advanced study in other Vedangas etc. , the selection committee may, at its discretion, recommend the person concerned (in the form of internship) for teaching at the Rashtriya Adarsh Veda Vidyalaya (RAVV), on payment of honorarium as applicable to different levels under the Pathashala scheme.
 - (4) Those who have not memorized the Veda Shakha thoroughly and do not possess proficiency in reciting Veda Vikriti, need not apply.
 - (5) Clear and sasvara chanting of Vedic mantras, knowledge of Bhashya, and knowledge of the meanings of the mantras are expected.

(I) Essential Qualification for the position of Principal-

1. Should be a Ghananta Paathee Vedic scholar who has studied Sasvara Veda from a Veda Guru.
2. Should possess 10 years' teaching experience of imparting high quality sasvara teaching in any of the one Veda Shakhas at any Veda Pathashala.
3. Should be well versed in Sanskrit language and Veda Bhashya.



Desirable Qualification

1. Worked in any Veda Vidyalaya/ Institute, in the capacity of Principal or have done administrative work.
2. Proficiency in working on computer and in handling Vidyalaya and hostel accounts, and other administrative tasks.

(II) Essential qualifications for the position of Veda Teachers

1. Should be a Ghananta Paathee who has studied Sasvara Veda from a Veda Guru/Sasvara traditional study of the Veda Shakha concerned/along with the Sasvara Veda Adhyayana (in any one of the Shakhas according to the Vedic tradition approved by the experts) obtained Masters degree from a University/Ghananta Paathee who has obtained traditional Certificate, in sasvara adhyayana of any one Vedas, from highly reputed Vedic institutions/ In Samaveda, one who has completed Rahasyanta Adhyayana and capable of melodious recitation of Samaveda/An eminent Vedic scholar in Atharvaveda.
2. Should possess 05 years' teaching experience of imparting sasvara teaching in the Veda Shakha concerned at any Veda Pathashala.
3. Complete memorization of the Veda Shakha concerned is mandatory.
4. Should be well versed in Sanskrit language and Veda Bhashya.

(I) Essential qualifications for Sanskrit teacher -

1. Must have obtained 55% marks in Graduate level Sanskrit degree and more than 60% marks in Postgraduate degree in Sanskrit from a recognized university OR Must have obtained 55% in Sanskrit/Shashtra in Shastri Degree and more than 55% marks in Sanskrit/Shashtra in Acharya Degree from a recognized university .
2. Shiksha Shastri / B.Ed.

Desirable Qualifications-

1. Ability to teach computer / Vedic Mathematics / any other subject in addition to Sanskrit.
2. Passed TET Exam in Sanskrit Language.
3. Possess good experience of teaching Sanskrit Sambhashan/ Bhagavad Gita/Amarakosha/Shabdarupa/Dhaturupa etc. at any Vidyalaya.
4. Proficiency in Sanskrit conversation in simple standard Sanskrit.

(II) Essential qualifications for Modern Subject Teachers (English, Mathematics, General Science, Social Science)

1. Should possess a degree in the subject concerned from a recognized university as mentioned below.

For the teacher of Mathematics :

- Must have passed B.Sc (Graduation) with Mathematics, Chemistry, Physics.
- Must have passed M.Sc. (Post Graduate) in Mathematics.

For the teacher of English :

- Must have studied English language as a subject in graduation.
- Must have passed M.A. (Post Graduate) in English.

For the teacher of General Science :

- Must have passed B.Sc (Graduation) with Physics, Chemistry, Biology.
- Must have passed M.Sc. (Post Graduate) in any of the science subjects viz. Physics, Chemistry, Biology.

For the teacher of Social Studies :

- Must have passed B.A. (Graduation) with History, Geography, Political Science, Economics.
- Must have passed M.A. (Post Graduate) in any of the subjects viz. History, Geography, Political Science, Economics.

2. B. Ed.
3. Must have studied Sanskrit Language at 10th OR 12th OR Graduation Level.

4. Must possess the ability to teach in Hindi and English.

Desirable Qualifications

1. Passed TET exam in the subject concerned.
2. Ability to teach any additional subject like Computer / Hindi language / Art etc., other than the subject concerned.
3. Proficiency in Sanskrit conversation and simple standard Sanskrit.

(III) Essential qualifications for Yoga Teacher

1. Must possess a Post Graduate degree in Yoga OR Sankhya Yoga OR Yoga Science from a recognized University.
2. Must be thoroughly proficient in practice and imparting training in all the Yoga Asanas, Pranayamas etc.
3. Must possess the ability to teach in Hindi, Sanskrit and English.

Desirable Qualifications

1. Studied Sanskrit Language/Vedas.
2. Possess Diploma in Yoga Therapy from a recognized University.
3. Possess QIC certificate.
4. Proficiency in Sanskrit conversation in simple standard Sanskrit.

(IV) Essential qualifications for Sports Instructor

1. Bachelor Degree from a recognized university in Physical Education.
2. Three (3) years' experience as sports-school teacher in any Vidyalaya.

Desirable Qualifications

1. Studied Yoga/Sanskrit Language/Vedas.
2. Postgraduate Degree from a recognized university in Physical Education.
3. Proficiency in Sanskrit conversation in simple standard Sanskrit.

(I) Essential qualifications for Warden

1. Must possess Postgraduate or Acharya Degree with Veda/Sanskrit/Yoga subject.
2. Must possess a certificate in Child Psychology/Child Guidance and Counselling.
3. Must possess two (2) years' experience as Warden in any Vidyalaya or Institution.

(II) Essential qualifications for Assistant Warden

1. Must possess Graduate or Shashtri Degree with Veda/Sanskrit/ Yoga subject.
2. Must possess a certificate in Child Psychology/Child Guidance and Counselling.
3. Must possess 1 year experience as Assistant Warden/Office Assistant in any school or institution.
4. Must possess the ability and experience to independently operate Word, Excel, PowerPoint on the computer, and to keep accounts of the consumption of food items in the hostel.

(III) Essential qualifications for MTS

1. Must have passed class 12th with Sanskrit Language / Vedas or Uttar Madhyama from a recognized board. **MTS will be engaged through out-sourcing only.**

(IV) Essential qualifications for Library Assistant

1. Must have passed B.Lib/Graduate in Library Science/Shastri from any recognized university.
2. Must possess a Graduation or Shastri degree with Sanskrit subject.
3. Two (2) years' experience as a Library Assistant in any Vidyalaya.

Library Assistant will be engaged on outsource/contract basis.



(I) Essential qualification for Assistant Staff for conducting Skill Development Courses

1. Must have passed Acharya/M.A in the Skill Development Course concerned.

Various arrangements and terms and conditions of Rashtriya Adarsha Veda Vidyalaya-

1. The engagement of teachers in Rashtriya Adarsh Veda Vidyalaya will be purely on the basis of temporary contract. There will not be permanent appointment or creation of posts. The teachers will also be responsible for the Pratishthan's Veda research, Veda research article writing, translation of Vedas into Indian languages, Vedic training, Veda printing proof reading, Veda Sabha, conference, seminar and other educational work under the duties of the principal or the teachers. Apart from the Veda Vidyalaya, all the arrangements of the hostel, keeping the students disciplined, following the time-table will be the responsibility of the teachers. As per the discretion of the Pratishthan and considering the need, transfer may be done to any other Rashtriya Adarsh Veda Vidyalaya under the Pratishthan.
2. Along with the oral tradition of Vedas, Brahmana, Aranyaka, Vedangas and other modern subjects will also be taught in Veda Vidyalayas.
3. Teaching arrangements will be made only if there are five or more than five students in each Shakha.
4. If found suitable for teaching the Vedas, but are found to be in need of experience and advanced study in other Vedangas etc. , the selection committee may, at its discretion, recommend the person concerned (in the form of internship) for teaching at the Rashtriya Adarsh Veda Vidyalaya (RAVV), on payment of honorarium as applicable to different levels under the Pathashala scheme.
5. Those who have not memorized the Veda Shakha thoroughly and do not possess proficiency in reciting Veda Vikriti, need not apply.
6. At the time of interview or samparikshan of Veda teachers, each teacher is required to bring with him the list of 10 students who are interested in seeking admission in R.A.V.V., and the admission details of those students in a form, permission letter from parents for admission in R.A.V.V.. Final engagement will be done only when students are available in each Veda subject and this condition will be applicable every year upon selection.
7. Teachers will have to perform tasks related to conducting examinations.
8. Rashtriya Adarsha Veda Vidyalaya is a residential Vidyalaya for the Vedic students.
9. Life in RAVV will be highly disciplined and based on adherence to Vedic custom, culture and Vedic knowledge.
10. Vidyalaya teachers and students will have to attend/live in traditional dress/ traditional costumes. It is compulsory for all the teachers (Vedas and other subjects) to wear traditional Vedic dress. (For men: dhoti-kachch, for women: sari and blouse)
11. The conduct of the teachers and students shall have to be as per Vedic tradition and etiquette; otherwise, punitive action will be taken.
12. Any kind of modern gadgets like mobile phone etc. should not be used in the hostel and school of Veda Vidyalaya. Use of mobile phones in the hostel, school, classroom or for personal use will not be allowed.
13. Computer literacy and proficiency is essential for teachers. They must possess ICT proficiency.
14. Every teacher will have to furnish a service affidavit on stamp paper of Rs. 100 and accept all the conditions.



15. If found suitable, relaxation in qualification, age and experience may be given at the discretion of the selection committee. The decision of the selection committee will be final and binding.
16. In all arrangements of the Veda Vidyalaya, the orders of the Secretary, M.S.R. V.V.P., Ujjain will be final and binding.
17. In case of selection on contract basis for Rashtriya Adarsh Veda Vidyalaya, Ujjain, it will be compulsory to stay in the accommodation provided on campus. For this, the prescribed fee will have to be paid.
18. Apart from the Rashtriya Adarsh Veda Vidyalaya timings, making the students self -study Vedas, reciting the Bhagavad Gita, progress inspection of students, morning sandhya, Agnikarya, morning Veda Parayan and Amavasya Veda Parayan will be the responsibilities of the Veda teacher and the teacher will have to be compulsorily present. Apart from Vidhyalaya timings, it is the responsibilities of the modern subject teacher to prepare the students for alphabet writing practice, English conversation, Sanskrit conversation, Vedic Mathematics, Science laboratory, General Science quiz, Yoga, etc. in modern subjects. There is no provision of additional honorarium for this purpose.
19. **The authority to accept, reject, partially cancel or re-invite the process related to the above services will be with the Secretary of the Pratishthan. No kind of litigation/dispute/ correspondence etc. will be valid in this matter. In case of any kind of legal dispute, the jurisdiction will be of the Hon'ble High Court of Madhya Pradesh, Indore Bench only.**

Note: Teachers and other non-teaching staff currently working on contract-basis in Rashtriya Asdarsh Veda Vidyalayas may also apply if interested.
