Note for Provisionally Eligible Candidates:

- The Tentative date of written test will be **19.07.2025 (Saturday)**.

(in Original) such as Aadhar Card/ Passport / Driving License / PAN Card / Voter Card etc. without which the candidates will not be permitted to appear in the Written Test. No photocopies of the above documents shall be entertained.
- The original certificates of their educational qualification and relevant experience mentioned in their application form will have to be produced before appearing in the written test.
- If at any stage of recruitment, the Education, Experience and Caste certificate of any candidate is found to be faulty, the candidature of such candidate shall be cancelled and he/she shall be barred for future recruitment in the MSRVVP.
- All the provisionally eligible candidates are required to submit the relevant documents as mentioned in the **Remarks Column** to MSRVVP through e-mail at: msrvvpurn@gmail.com on or before **31 May, 2025**. The Pratishthan will not consider any request for extension of time for submission of documents beyond the stipulated date.
