## Notification-1866

### Subject: Inviting applications for organizing various programmes in the year 2026-27-reg.

The main objective of the Maharshi Sandipani Rashtriya Vedavidya Pratishthan, Ujjain is to preserve, promote, propagate and disseminate the Shruti tradition of the Vedas. The Pratishthan carries out various programmes and activities to achieve the objectives enshrined in its Memorandum of Association. The following programmes under the various schemes of the Pratishthan are to be organized during the year 2026-27 :-

1. All India Vedic Conference
2. Regional Vedic Conference

The in person presence of the Head of the organizing Institution will be mandatory during the entire duration of the All India Vedic Conference/Regional Vedic Conference and in the Veda Shobha Yatra. It is mandatory to engage the teachers of your Institution, teachers of nearby GSP Units and Veda Pathshalas, Vedic students and people of the society in the Veda Shobha Yatra. The Institution must organize the Veda Shobha Yatra on the first day or second day of the conference itself.

Only the Institutions which consent to this should apply for organizing All India Vedic Conference/Regional Vedic Conference; otherwise, the application will not be considered and taken into account.

3. All India Vedic Seminar
  4. Veda Jnana Saptah Celebration
  5. Vedic Classes for All
  6. Veda Sandesh Yatra - Veda Sandesh Yatra by the financially aided Pathashala/financially aided GSP Unit.
  7. Veda Parayana - Veda Parayana by the Institution
- Only organizations having Unique ID in NGO-Darpan portal of NITI Aayog should apply. However, Central and State Universities are exempted from this.
  - To organize Vedic Seminar applications may be submitted through Central/State University/Head of Department/Vice-Chancellor or Registrar.
  - To organize other programmes application may be submitted through the Chairman, Secretary or other officials of the organization.

Application form for organizing various programmes in the year 2026-27 under the above mentioned schemes may be downloaded from the website of the Pratishthan - [www.msrvvp.ac.in](http://www.msrvvp.ac.in) and filled in applications may be sent to email [msrvvpproject@gmail.com](mailto:msrvvpproject@gmail.com) and by hard copy to the Pratishthan via Speed Post by 27<sup>th</sup> February, 2026. It is mandatory for the organising body to provide information regarding amount to be spent by it on the Programmes. Institutions which have organised programmes once in the last three years will not be granted permission to organize the same programme again. Similarly, institutions that fail to organise programmes despite having obtained approval in the past shall not be granted permission again. Applications received after the last date will not be considered.

**Note :- Under no circumstances shall applications pertaining to any of the aforementioned programmes be entertained during the middle of the year. The institutions concerned may submit their applications within the stipulated timeframe.**
