### Notification-1981

**Sub: Compulsory participation of Veda teachers engaged in Veda Pathshalas in Continuous Professional Development Course (CPDC) /Refresher Course-reg.**

**(A) Continuous Professional Development Course (CPDC)**

The National Education Policy (NEP 2020) has been implemented by the Government of India with effect from 29 July, 2020. Under the Pratishthan the students study both Veda and modern subjects from Class VI to Class XII and are awarded certificate equivalent to that of the Board. The Pratishthan is not an institution for disbursing only grants. Being also an educational institution related to Vedas, it is mandatory for **every teacher** of Veda Pathshalas/Guru-Shishya Parampara Units to regularly take part in Continuous Professional Development Course (CPDC) for 50 hours, as required under the National Education Policy. Since this requirement emanates from the National Education Policy issued by the Government, it is applicable to all teachers, whether existing or newly engaged, and irrespective of whether they teach Vedas or modern subjects. Participation in the said course is mandatory for all, and exemption will be NOT be granted under any circumstances.

**(B) Refresher Course**

With the approval of the Ministry of Education, Government of India, the honorarium of Veda and modern subject teachers engaged in Veda Pathshalas/GSP Units, financially aided by the Pratishthan, as well as the stipend of the students, has been enhanced with effect from 01.04.2023.

A number of Veda teachers working for the last several years in the Veda Pathshalas financially aided by the Pratishthan, have not yet participated in the refresher courses/training programmes conducted by the Pratishthan in the previous years. It is essential for such teachers to undergo at least one Refresher Course/Training Programme upon completion of five years of service and two Refresher Courses/Training Courses upon completion of ten years of service. Accordingly, teachers of all the Veda Pathshalas/Guru-Shishya Parampara Units are hereby informed that Veda teachers who have completed five or ten years of service are required to participate in a 15-day Refresher Course being organized by the Pratishthan from 01.05.2026 to 15.05.2026 at the Pratishthan campus, Ujjain, in order to avail the benefit of enhancement in honorarium. The Refresher Course will include Veda Swadhyay, lectures on topics related to Vedas, Veda Shakha Parayana, study of essential modern subjects, educational innovations, deliberations on Veda Vidyalaya management, and lectures on various other topics on a daily basis.


